Balance Payment : Before entry into the boat, balance payment will be paid in cash to the Bella Yachting representative.

Services Included in the Price: Transitlog, port costs, diesel, petrol, personnel services, boat water, 3rd party personal accident insurance (we recommend that you do your holiday insurance).

Services not included in the price: Dalaman airport departure - return transfer. Drinks consumed from the boat bar (other than your own drinks), land tour and entrance fees to the ruins, water sports, marina binding expenses outside the program.

5. Start of the Tour Information;

- Smoking in the boat is strictly prohibited and you are kindly requested to be sensitive about it. On the deck, it is possible to smoke, but be careful in the windy weather and maximum care is taken to avoid any unwanted conditions.
- Toilet paper must be thrown into the waste basket. Care should be taken not to leave foreign materials in the toilets.
- Service boats water sports equipment should not be used without captain knowledge.

This information will be reminded to you before the tour. However, due to these reasons, our agency will not be responsible for any problems that may occur in the boat or tour program.

6. Cancellation Policy;

- For cancellations up to 90 days before the tour date, 20% of the tour price is canceled and canceled.
- For cancellations made 60 days before the tour date, 30% of the tour price is canceled and canceled.
- For the cancellations made 30 days before the tour date, the deposit is not refunded. However, they can cancel the 30% of the total tour price and can cancel the boat they have canceled on the same boat or on another boat next year.
- In case of cancellations made 14 days before the tour date, the total cost of the tour is requested.
- Refund in tour cancellations; 30 days after the cancellation date.

7. Our Obligations;

The service guarantee we offer at Bella Yachting is in line with quality service obligations. The reservations and agreements concluded as Bella Yachting have been realized by taking into consideration the agreements and conditions determined in accordance with Turkish Laws. In case the service to be offered cannot be provided for any reason other than our company (boat failure, air opposition etc.),
